Our site's subscription form requires users to give us contact information (to include names and E-mail addresses), financial information (to include account or credit card numbers), and demographic information (to include zip code). We use customer contact information from the subscription form to send the user information about our company and promotional material from some of our partners. The customer's contact information is also used to contact the visitor when necessary. Users may opt-out of receiving future mailings; see the choice/opt-out section below.

Collected financial information is used to check the users' qualifications for subscribing and to bill the user for products and services ordered. Demographic and profile data is also collected at our site. We use this data to tailor the visitor's experience at our site, showing content that we think may be of interest and displaying content according to preferences. This information is shared with advertisers on an aggregate basis only.

Information collected and how do we use it?

When you order, we need to know your name, email address, mailing address, credit card number, and credit card expiration date. This allows us to process and fulfill your order and to notify you of your order status.

When you sign up for services like Newsletters, we need only an email address which we use to send the information you requested.

We may also use the information we collect to occasionally notify you about important functionality changes to the web site, new services, and special offers we think you'll find valuable. We send this information to if only you allowed us to do that by checking Add to Mailing List box on your order form.

When you enter a contest or other promotional feature, we may ask for your

name, address, and email address so we can administer the contest and notify winners.

How do we protect customer information?

"Cookies" are small pieces of information that are stored by your browser on your computer's hard drive.
